



OFFICIAL CONTEST RULES

ELIGIBILITY

LAWineFest's 20th Anniversary Prize Giveaway (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least twenty-one (21) years old at the time of entry. Employees of LAWineFest, LLC and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

CONTEST PERIOD

The Contest begins on February 01, 2025 at 12:00am PST and ends on June 01, 2025 at 3:00pm PST (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods:

HOW TO ENTER

On-Site: By ticket purchase available only on the days of the fest at Harry Bridges Memorial Park, 1126 Queens Hwy, Long Beach, California 90802.

Online: This method of entry will be available by visiting our website (www.lawinefest.com) and purchasing a ticket to the fest prior to the first day of the fest (5/31/25) or by purchasing a ticket through one of our ticket brokers (Bucketlisters and Rush 49).

Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

PRIZE DRAWING

On May 31, 2025 and June 1, 2025, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will announce the winners on site at specified times during the hours of the Fest. *Random Picker (Official Winner Generaor)* will choose the prize winners at complete random.

WINNER NOTIFICATION

Winners will be announced from the main stage and the names will be displayed on display screens at the stage. If the potential winner cannot be contacted within three (3) business days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries. The "Grand Prize" winner will be announced on Sunday, June 1st at the fest location. If the winner is not present during the announcements, he/she will be contacted by phone, email, or text message. Once contacted, the "winner" will have three (3) business days to respond and claim their prize.
